SPECIAL TERMS AND CONDITIONS FOR REGISTRATION OF PLAYERS

1. General Requirements

1.1. All clubs affiliated with the Greater Durban Football Association (GDLFA) shall ensure that the player registration process is conducted in full compliance with the terms and conditions set forth herein.

1.2. Clubs shall verify and ensure that all information provided in player registration forms is accurate, true, and correct before submission to the GDLFA.

2. Junior Player Registration

2.1. For the registration of junior players, clubs must confirm that the parent or legal guardian of the junior player has expressly signed the registration form. No registration shall be deemed valid without this confirmation.

2.2. Clubs are responsible for retaining and providing proof of the parent or legal guardian's signature on the registration form when requested by the GDLFA.

3. Sanctions for Age and Identity Cheating

3.1. In the event of age cheating in the Junior Division, the club involved will forfeit all points for games in which the offending player participated, as determined by the GDLFA's Player Registration Committee.

3.2. In cases of player identity cheating in the Senior Division, the club will similarly forfeit all points for games where the violation occurred.

3.3. The decision of the Player Registration Committee regarding age or identity cheating shall be final and binding.

3.4. The sanctions outlined in this section do not preclude the association from proceeding with formal disciplinary action in terms of the SAFA Competition Rules.

4. Compliance with the Protection of Personal Information Act (POPIA)

4.1. Clubs are required to comply with the Protection of Personal Information Act (POPIA) while ensuring that the provision of identification documents is not withheld under the guise of POPIA.

4.2. By affiliating with the GDLFA, clubs acknowledge and agree to provide the necessary identification documents for the purpose of player registration and investigations related to player eligibility.

4.3. The GDLFA guarantees that all personal information and identification documents submitted will be securely stored, safeguarded, and accessed only by authorised personnel. This information will strictly be used for player registration and any related investigations.

4.4. Failure to provide the required documentation will render the player's registration null and void.

5. Enforcement

5.1. All clubs agree to these terms and conditions as a condition of their affiliation with the GDLFA.

5.2. The GDLFA reserves the right to amend these terms and conditions with due notice to affiliated clubs.

6. Acknowledgment By affiliating with the Greater Durban Football Association, each club acknowledges that it has read, understood, and agreed to these terms and conditions for player registration.
